- A Technical Assistance Program for EU Member States.

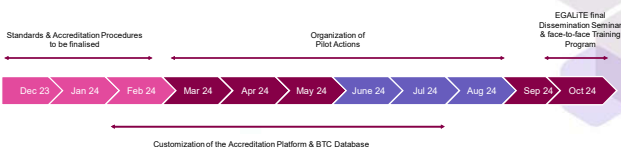
