GDPR

The following communication has been emailed to all EBMT members from the Executive Committee.

Dear EBMT Member,

EBMT is strongly committed to protecting the privacy of personal data that we maintain about patients, members and employees. As you may know, the General Data Protection Regulation (EU 2016/679) (GDPR) will be enforced on the 25th of May and in this context, we would like to take the opportunity to inform you about how EBMT processes patient personal data. For more information, please read the <u>EBMT Patient</u> <u>Personal Data Protection Statement</u>.

Additionally, EBMT has developed a template <u>Consent Form</u> <u>For Data Registration With EBMT</u> to fulfil the GDPR requirements and to support EBMT Centres and National Registries in their implementation at a national level. The template has been produced by the EBMT GDPR working group, revised by the EBMT Board of the Association and Scientific Council, revised and endorsed by the EBMT legal advisors for compliance with GDPR, and finally approved by the EBMT Executive Committee. This consent form template is meant to be used as guidance and may need to be adapted in accordance to specific national regulations and the needs of the centre. The EBMT's objective with the development of this template is to assist its Centre Members in the process of GDPR implementation as much as possible.
