This project is a collaborative activity with the Pediatric Diseases Working Party, Pediatric Nurses Committee & Nurses Research Committee of the EBMT. Currently an article is in the process of preparation to be published.

Skin Care Project

We are working on a Delphi survey with the aim to create recommendations on prevention and management of conditioning related skin toxicity in paediatric HSCT patients.
