- Request removal: If your image has been published and you wish to have it removed, you may contact EBMT at data.protection@ebmt.org.
- Access and correction: You may request access to any personal data EBMT holds about you and request corrections where necessary.

## **Retention and Security**

Photographs and videos are stored securely and retained only for as long as necessary to fulfill the purposes outlined above. EBMT implements appropriate technical and organizational measures to protect personal data against unauthorized access and misuse. If you no longer wish for your photos to be used or shared, please contact us using the details provided below, and we will take appropriate action to honour your request.

### **Third-Party Sharing**
