Update on the Registry Upgrade Project

Throughout the year we will be working with our new technology partner, Remedy Informatics. Following the overview presentation at EBMT 2013, we would like to update you on the current status of the project: Final requirements have been completed and approved. The platform has already been upgraded so that users will be able to work directly through their internet browser, without downloading any additional tools. Configuration is still proceeding, to be accompanied by data migration and testing. We would very much appreciate your help with the data quality checks below to assist with the data migration process. Tentatively, the plan is to train EBMT and National Registry staff later in the year. Following this we will roll out the training to Centre users. The dates are still to be announced. We anticipate to have a clearer schedule by the end of August.

Data Quality Checks

In relation to the Registry Upgrade mentioned above, this is a very good opportunity for Centres to look again at their data and to check the Data Quality before it is transferred into the new system. Some records may not be transferable if the data is not coherently recorded.

Data Quality reports

Many national registries are in regular contact with centres regarding missing items, data discrepancies and follow up updates. However not all centres have this contact, so this appeal is to those centres in particular.

For users who currently have access to ProMISe, a good place to start is to run the Data Quality Reports which are available to all centres. (Even if you do not use ProMISe to submit data, you can still apply for access in order to check your centre's data registration status and quality) These reports can help you to identify some key issues such as invalid data, missing data, duplicate information, incorrect diagnosis, error messages and conflicting information. The reports are straightforward to run – they make it easy to see where data is missing or wrongly entered and then you will have the opportunity to correct the errors.



Follow Up due

We would also like to remind you of the importance of regular follow up reporting. This is a crucial contribution for the analysis of outcome data. In November 2012, the Registry Office sent follow up reminders to all centres containing patients without a follow up report for at least 5 years.

You can also run a pre-programmed report in ProMISe to generate a list of your patients last seen more than one year ago, more than 2 years ago, or more than 5 years ago. To run these, follow steps 1-4a in the above guide but select from these report titles:
