EBMT Registry is going paper free

Below is a reminder of the announcement from the **EBMT Board** that was sent to Principal Investigators in July, together with an online survey to establish the best way to support centres:

For 42 years EBMT has provided support to centers entering data, however, the EBMT Board is now taking steps to go paper free in 2017. This means that data entry of standard paper forms - MED-A, MED-B and Follow Up - will no longer be offered by EBMT.

Most EBMT centres have already moved from paper to online data entry but 10% of centers remain dependent upon the Registry in London to enter their data manually.

By moving to the paper free data entry we not only expect to increase the quality of our database, but also expect a more effective process in your center, as experienced also by many other centers across Europe. Finally we commit ourselves as EBMT to be friendly to our environment.

The EBMT has agreed to:

- allocate a budget for a data entry training course in a central European city
- continue to organise the data entry training course during the EBMT annual meeting in Marseille
- provide on-line training tools and maintain the helpdesk support

Upgrading the registry system in 2020 has become crucial to undertake new projects and the new Registry aims to be a more user-friendly tool by:

- · integrating data quality
- · increasing the efficiency of data collection and retrieval
- · developing a collaborative tool that can be used by other partners.

In addition to this criteria, the EBMT must extend the Registry to cellular therapy products and link clinical data to bio banking for a defined subset of patients arising from defined EBMT activities.

As requested by many data managers, MED-A forms separated by diagnosis and graft type are in the process of being made available online

Launch of ProMISe 4

As you may have read on the ProMISe logon page, the upgrade to ProMISe version 4 will take place on the 5-7th November 2016. The main feature of ProMISe 4 will be to start becoming compatible with other browsers (e.g. Chrome, Firefox) in addition to Internet Explorer.

On Saturday Nov 5th all servers go down in the evening. The servers will be closed on Sunday 6th and part of Monday 7th for upgrade. **ProMISe 4** is expected to be available on **Monday 7th November** (exact time TBC). For updated info please visit the <u>ProMISe logon page</u>.

We have been notifying users who are still on IE8 to try to get their browser upgraded urgently. Support is already limited for IE8 and by the end of this year it will become obsolete. Users should upgrade to at least IE9 but preferably IE11.
