

Prospective Clinical Trials

2 trials are recruiting patients / in set-up phase:

- <u>AAWP</u>: RACE compares standard IST (ATG + CsA) plus Eltrombopag vs Standard IST alone.
 - This EBMT study is financially supported by GSK and Pfizer. 31 EBMT Centres will enroll patients. The study is in the set-up phase with EC and CA submissions ongoing. First patient in planned for May 2015 in France/Italy.
- <u>CQWP/IDWP</u>: <u>CMV prophylaxis</u> phase III RCT to Evaluate the Safety and Efficacy of MK-8228 (Letermovir) for the Prevention of CMV Infection in adult, CMV-Seropositive Allogeneic HSCT Recipients.
 - This Merck sponsored trial is supported by the EBMT (recruitment and retention services) – 158 out of 540 patients have been recruited.

2 trials were published in the last year:

- <u>ADWP</u>: **ASTIS** was published in 2014 in JAMA and long-term follow-up (5 years) completes in 2017. **ASTIMS** was published in 2015 in Neurology and is now complete.
- The CT2 committee is open for new CT proposals (deadline = 17 Apr 15)



Transplant Activity Survey 2013



- Hematopoietic SCT in Europe 2013: recent trends in the use of alternative donors showing more haploidentical donors but fewer cord blood transplants. Passweg JR et al. *Bone Marrow Transplant*. 2015 Feb
 - 39 209 HSCT in 34 809 patients were reported by 658 centers in 48 countries to the 2013 survey.

Trends:

- More growth in allogeneic than in autologous HSCT
- Increasing use of sibling and unrelated donors
- Pronounced increase in haploidentical family donors when compared with cord blood donors.

Main indications:

Leukemias: 11,190

lymphoid diseases: 19,958

solid tumors: 1,543

Non-malignant disorders: 1,975

Indications for allo- and auto-SCT for haematological diseases, solid tumours and immune disorders: current practice in Europe, 2015

This is the sixth special report that the European Society for Blood and Marrow Transplantation regularly publishes on the current practice and indications for haematopoietic SCT for haematological diseases, solid tumours and immune disorders in Europe, Major changes have occurred in the field of haematopoietic SCT over the last years. Cord blood units as well as haploidentical donors have been increasingly used as stem cell sources for allo-SCT, thus, augmenting the possibility of finding a suitable donor for a patient. Continuous refinement of conditioning strategies has also expanded not only the number of potential indications but also has permitted consideration of older patients or those with co-morbidity for a transplant. There is accumulating evidence of the role of haematopoietic SCT in non-haematological disorders such as autoimmune diseases. On the other hand, the advent of new drugs and very effective targeted therapy has challenged the role of SCT in some instances or at least, modified its position in the treatment armamentarium of a given patient. An updated report with revised tables and operating definitions is presented.







Scientific context and Background

- Major advances related to breakthrough results achieved with newer immunotherapeutic agents and advanced cellular therapies

Financial Report 2014



Treasurer Financial Highlights

- After 3 years of governance and structural changes, we have succeeded in reducing the financial risks. Today, EBMT has mechanisms of control in place that demonstrate clear lines of accountability through transparency, which has resulted in an official audit of the financial statements by third party auditors during 2014.
- In 2014, EBMT has increased from 80% to 84% the expenses dedicated to its Mission (Studies, Registry, Accreditation and Education) and the reduced to 16% the expenses allocated to Management (Board and Executive Office expenses)
- EBMT will end the year with a total surplus of 141K€. The 2014 surplus will be returned to the reserves which will strengthen the financial position of EBMT. This financial situation therefore allows an increase in personnel to be allocated to scientific studies, which will be overseen by the Working Parties in 2015.





- EBMT has changed the awareness and behavior of the employees within EBMT regarding internal control procedures
