# **Standards**

### **5th edition overview**

The Standards Development Steering Committee initiated the development of the 5th edition of the FACT-JACIE International Standards for Cellular Therapy Product Collection, Processing, and Administration this June in Barcelona, Spain. The purpose of this meeting, led by Carolyn Taylor, PhD, Standards Chair, was to review comments and survey responses submitted by cellular therapy programmes, establish overall goals for the new edition, and coordinate subcommittee activities.

The draft of the 5th edition will be available for public comment in mid-2011, with the final version being published in March 2012. Details and updates regarding the Standards development process will be provided as they become available.

# News

### **Overview**

Since 2000, JACIE has received 214 applications from centres in 17 countries. This is testimony to the global appeal and relevance of the FACT-JACIE standards.

### **Preparation for Inspection**

Centres preparing for an on-site inspection must submit what can be a substantial quantity of documentation in advance. The list of documents is available in the Inspection Guide version 4.6 from the Document Centre on the JACIE web site.

Most centres submit carefully organised and presented collections of documents which greatly facilitates the task of the inspectors when they come to review the files before the inspection. Occasionally however submissions are less clearly organised or files have titles that make it difficult to know what they refer to. This can make the inspectors' task more difficult and time-consuming.

In order to help centres and standardise the way documents are submitted, the JACIE Office has released a new tool based on a zip file that contains a pre-formatted series of folders and sub-folders for each section of the standards that the centre can use to group and classify their files. The zip file and instructions are available from the Document Centre on the JACIE web site.
